Due to the nature of the natural vitamin E manufacturing process, small amounts of non- α tocopherols and/or other vegetable oil constituents may be present in Provitas[®] EF1490. Provitas[®] EF1490 is designed for use in oil dispersions, encapsulated products, fortified food and personal care products.
