Stability-

The shelf life in sealed, original containers stored at ≤25°C/77°F and well protected from light and excessive heat exposure is 24 months after the date of manufacture.

Storage-

Store in tightly closed containers at $\leq 25^{\circ}\text{C}/77^{\circ}\text{F}$. Vitamin K is especially sensitive to light; protect from light, heat and oxygen. If opened container and partial contents are to be stored, flush contain of oxygen with an inert gas and tightly reseal.
